

Instructions on IEEE ICAL 2011 Paper and Digest File Submission

1. All accepted final papers must be submitted electronically, accompanied by a paid registration. The registration form can be downloaded from the conference website.
2. The submission of your final paper PDF file and the single-page Digest PPT file must be submitted electronically together with the author registration by July 15, 2011.
3. Each accepted paper is limited to six (6) pages in the standard IEEE conference double-column format. Authors may submit paper manuscripts up to a maximum length of eight (8) pages, with an over-length extra-page fee of HK\$780 (~US\$100) for each additional page beyond six pages. Each author with a paid regular registration can cover up to two papers with the second paper being charged an extra paper fee of HK\$2,340 (~US\$300). Each student author with a paid student registration can only cover one paper of the student author. Each final paper submission must be accompanied by a paid registration. Otherwise the paper will not be included in the conference Program nor the conference Proceedings.
4. Please make sure that all the fonts in text/figures/pictures/tables/equations of your paper PDF file are properly embedded and subsetting. We strongly suggest that you produce your final paper PDF file using the IEEE PDF eXpress service. Instructions on how to use IEEE PDF eXpress account to produce your final paper PDF file and to check the IEEE Xplore PDF compliance can be found on the website.
5. By accepting your paper, we request that you or your co-author register for IEEE ICAL 2011 conference and present your paper at the conference via oral presentation. Completed registration with payment for authors who submit the final version of their accepted papers by July 15, 2011 is due at the same time of the final paper submission on July 15, 2011. If no author of a submitted final paper registers by July 15, 2011, the submitted paper will not be included in the conference Program nor the conference Proceedings. If you or anyone of your co-authors cannot register or present your paper at the IEEE ICAL 2011 conference, please inform us via email to the conference secretariat immediately.
6. On-line electronic final paper submission must consists of:
 - a. An IEEE Xplore Compliant (IEEE PDF eXpress check passed) PDF file with file size limited to 5MB;
 - b. The E-mail confirmation that the IEEE PDF eXpress services send to you after your PDF file passes the IEEE PDF eXpress compliance check (save your email in a txt file);
 - c. A single-page Digest PPT file to be used in the IEEE ICAL 2011 conference Program Digest Book; &
 - d. Completed and signed IEEE Copyright form submitted from the final paper submission website.
7. Please follow the submission steps on the conference website to submit your final paper.
